### Discipline Rift (Torres Rivero LLC) — Messaging Program

#### Program Description

By providing your mobile number and opting in, you agree to receive recurring transactional and marketing SMS/MMS messages from Discipline Rift (Torres Rivero LLC) and its independently owned franchisees (“we,” “us,” “our”). Messages may include account/registration updates, reminders, schedule changes, alerts, confirmations, and promotional offers related to our programs and events.

#### Message Frequency

Message frequency varies (e.g., season updates, reminders, alerts, and occasional promotions).

#### Cost & Carriers

Message and data rates may apply. Carriers are not liable for delayed or undelivered messages. Delivery subject to your carrier’s network performance and device compatibility.

#### Consent Not a Condition

Your consent to receive texts is not a condition of any purchase or program enrollment.

#### Opt-Out (STOP)

You may cancel the SMS service at any time. Text STOP to any message from us. After you text STOP, you’ll receive a one-time confirmation text, and then you will no longer receive SMS/MMS from that program number.

#### Managing Preferences

If available, you may also manage subscriptions in your Account → Contact Preferences after signing in.
